Voucher for Health Pilot Project at Jhang District, Punjab

_____, GoodLife (GL) provider, Jhang and Greenstar Social Marketing Pakistan (G) Limited are pleased to announce their cooperation to pilot "Voucher for Health" Project. The main feature of this cooperation will include:

1. Greenstar will give vouchers for maternal and newborn health and family planning services to pregnant women of low socioeconomic status, in 11 rural Union Councils of Jhang district.
2. These pregnant women will redeem the vouchers at the clinic of the said GL provider.
3. GL provider will provide services against each voucher redeemed according to the agreed parameters.
4. GL provider will make the payments to client as per below table for her transport cost. GL provider will also charge her service charges from Greenstar on redemption of each voucher except when the client comes for delivery, she will be paid Rs500/- (rupees five hundred and only) for transport cost. A maximum of Rs950/- will be paid to the client for transportation cost.
5. Greenstar will collect voucher on bi-monthly basis from the provider and will pay the provider the cost of the voucher along with the transport cost paid by the provider after verification of the redeemed voucher not later by the 25th of the next month. Total cost of the vouchers will not exceed Rs4,000/- per client for normal delivery.

7. GL provider has to prepare pantograph of each delivery conducted by her and will keep the client under her observation for 24 hours.

8. The Memorandum of Understanding will extend for a period of 12 months from the date of its signing.

We anticipate that this endeavour will help in increasing use of skilled birth attendants and eventually reduce maternal and newborn morbidity and mortality in Pakistan.
